The Program

The Summer School Program is conceived of as an educational and informational tool for Italian and Qatari students who want to develop transnational legal skills and be exposed to other legal settings. The Program will introduce students to contemporary legal issues in Europe and the Middle East, while also facilitating job search and business activities in the global legal context. The two-weeks Program devotes some preliminary lessons to foundational aspects of European and Middle Eastern Law, with a special focus on Italian Law and Qatari Law. Then it addresses the legal layers of economic and business activities that define the interaction between these regions. The doctrinal sessions are supplemented by workshops and talks with practitioners in the relevant legal and business fields of importance to the Italian and Qatari economies.

The Venue

The courses will be held at the University of Padua in Treviso and at the Unindustria Treviso headquarters. Treviso is a lively town 20 minutes away from Venice; it has become one of the capitals of the new generation of Italian businessmen and the hub of high-quality economic activities. The tight connections between the University and the industry unions that are present in the territory make it the perfect place for the Program.

The Students

The Program is primarily offered to Law School students; other candidatures will be also considered.

The Department of Public, International, and Community Law (DiPIC) will issue a certificate attesting the participation in the Program. It will also offer ECTS (CFU) to the students who will take a final exam at the end of the Program.
